# 5.Proposition 68 Well 6 Water Treatment Plant

Construction is complete, pending a few warrantee items. Start up was initiated under the review of DDW. Full operation is pending test results that confirm the treatment is reducing arsenic concentration below the maximum contaminant level.

### 6. Proposition 68 Drinking Water Construction Grant for New Well No. 7

Construction is in progress. Clark Bros has re-mobilize after equipment delays, and work is moving forward.

# **Determination of CDBG Project Application**

District staff has recommended one CDBG project for which to submit an application for funding assistance. Funding assistance applications are due by the end of August 2024. The project includes:

1) Replacement of old fire hydrants with new dry barrel style hydrants.
