Public Hearing

A Public Hearing is offered to receive input from the community regarding suggestions for a CDBG Project to consider for an application to be submitted by September 26, 2025.

Determination of CDBG Project Application

Upon consideration of any comments received during the Public Hearing, proceed with selection of a project to be submitted for consideration by the County of Fresno for funding assistance. District staff has recommended one CDBG project for which to submit an application for funding assistance. Funding assistance applications are due by September 26, 2025. The project includes:

- 1) Installation of an emergency standby generator at the West Water Storage Tank site.

Recommended Action: Identify the project and the District will submit a funding application to the County of Fresno.

6.Proposition 68 Drinking Water Construction Grant for New Well No. 7

Construction is complete. Final reimbursement claims have been submitted to the State. CCSD is holding final retention to ensure everything is operating properly at the site.

Recommended Action: Board's pleasure.

7.ARPA West Water Storage Tank Project

A Notice to Proceed was issued to Hartzell on August 4, 2025.

Potholing has been completed. Currently in the submittal review and equipment procurement process. The Contractor plans to start clearing grubbing and doing site work in late September/early October.

Recommended Action: Board's Pleasure

8.Drinking Water Planning Grant for Well 3 & 5 TCP Treatment

A construction funding application was submitted for TCP treatment at Well 5.

The State has issued a Return to Compliance letter, stating that the water system has been returned to compliance for TCP as of April 2025, since Well 5 has had non-detect levels of TCP since 2023.

Recommended Action: Board's Pleasure

9.Cross Connection Control Program

Water systems must prepare a Cross Connection Control Plan by July 1, 2025. DDW has approved an extension request to October 31, 2025.
